Victorian Skateboard Association: Member Protection Declaration

The Victorian Skateboard Association is committed to the health, safety and general wellbeing of all its members and participants. The organisation is dedicated to creating a safe, fair and inclusive environment for members and providers participating in Victorian skateboarding activities, and through this Policy we aim to ensure that everybody involved in skateboarding is aware of his/her/their rights and responsibilities.

Victorian Skateboarding Association has put in place a Member Protection Policy that provides key procedures that support our commitment to preventing and eliminating discrimination, harassment, child abuse and other forms of inappropriate behaviour. The Victorian Skateboard Association values the importance of making a sporting environment that is fair, equitable and safe for all Victorian communities and provide equal opportunity for all participants to enjoy skateboarding, whatever level they may be undertaking.

The following documentation provides mandatory guidelines for persons association with the Victorian Skateboard Association, including adherence to Code of Conduct and Working with Children Check and other employment screening requirements.

MEMBER PROTECTION DECLARATION

Victorian Skateboard Association has a duty of care to all those associated with the sport at state level and to the individuals and organisations to whom our state Member Protection Policy applies. As a requirement of our state Member Protection Policy, Victorian Skateboard Association must enquire into the background of those who undertake any work, coaching or regular unsupervised contact with people under the age of 18 years.
